Sandridge Parish Council continues to object to this proposal for a single storey front extension as it believes that this constitutes overdevelopment of the site contrary to Policy D4 (3) – 'The scale and height is in keeping with existing and adjacent buildings'. SPC also believes that the proposal is contrary to Policy D4 (4) 'New developments and extensions

	including a new bedroom should provide off-road car parking with a minimum of two spaces'. The proposed additions to the rear of the building remain acceptable."
